

Brea - Part I & II Crimes Overview

The California Department of Justice (DOJ) Uniform Crime Reporting (UCR) is a city, county, and state law enforcement program. This program provides a statewide view of crime, based on the reporting of statistics by law enforcement agencies throughout the state. Every crime report is evaluated according to the UCR requirements/guidelines and is classified by seriousness and frequency, with Part I crimes considered the most serious.

Listed below are the Part I & II crimes reported in the City of Brea. They are categorized by crime type. Statistics are preliminary and subject to further analysis and revision.
